3. Once you submit your Poquott Mooring Application to Village Hall (with your Poquott payment of \$100), we will then forward a copy to Brookhaven and only then will they issue your Brookhaven Mooring Permit.

The VILLAGE OF POQUOTT and its OFFICIALS assume no responsibility of any vessel or its gear stored on the rack, nor for any damages sustained to any such vessel or its gear while so stored, nor for any sort of injury to any and all persons resulting from contact with such equipment. I attest that the equipment described above is sea worthy and is in active use, that all information I have supplied is accurate and truthful, and that I accept the terms of this AGREEMENT. I further agree that placement of any vessel on the rack will be assigned to me and **I agree to remove my boat from the rack prior to December 1st** and to immediately comply with any notification I receive from the Village to remove my vessel for any reason the Village deems necessary. I also agree to pay any fines associated with the use of the Boat Rack that is not in compliance with any of the provisions contained in Chapters 43, 99, 132, 161, 162 and 173 of the VILLAGE OF POQUOTT Code. **I agree to remove my boat from the rack prior to December 1st** *The undersigned does hereby Hold Harmless, indemnify and defend the Incorporated Village of Poquott from any and all liability, loss, damage, expenses, claims, suits or proceedings and cause of actions of any kind and nature arising out of the aforementioned Boat Mooring.*
